YES Practice Manual Version 3 now available

Version 3 of the Youth Empowerment Services (YES) Practice Manual has been posted to the YES website, in both PDF and E-book format. A Spanish version should be available soon.

This new version of the practice manual includes a new chapter dedicated to applying the Principles of Care and Practice Model, which was previously in the Planning Coordinated Care chapter. It also contains new and clarifying information in several other chapters on topics like the Coordinated Care Plan, Wraparound Intensive Services (WINS Idaho), Team Processes, Children's Medicaid, Optum Idaho outpatient service requests, and the Division of Behavioral Health complaint process.

There are also now convenient links from the beginning of each chapter to the Terms to Know section.

The QMIA Report is assembled with information about children, youth, and families in Idaho and from data collected by the Department of Health and Welfare's Divisions of Behavioral Health (DBH), Medicaid, and Family and Community Services (FACS), as well as the Idaho Department of Juvenile Corrections (IDJC), and the Idaho State Department of Education (SDE).
