## YES Resources for Providers and Educators Available

# Set Up Your Agency in ICANS by June 30 to Use Simplified Process

For a limited time, provider agencies can use a simplified process to set up their agency and providers to use ICANS. ICANS is the State of Idaho's secure, electronic, internet-based system to administer and manage CANS (Child and Adolescent Needs and Strengths).

Application paperwork must be signed and sent into the ICANS Help Desk by June 30, 2019 to be eligible for simplified setup.

Step-by-step instructions on the initial set-up process are on the ICANS website, Resources and User Guide.

Note that ICANS training does NOT result in a CANS certification. ICANS users who need to be able to sign off on a CANS assessment must



also be certified by the Praed Foundation.
