- **IBHP:** Idaho Behavioral Health Plan Governance Bureau, Division of Medicaid, Idaho Department of Health and Welfare. This team monitors and manages Medicaid's IBHP contract with Magellan Healthcare.
- **IDHW:** Idaho Division of Health and Welfare
- **Other State Funding:** State general funds, grants, etc. through the Division of Behavioral Health (DBH) or Child, Youth, and Family Services (CYFS), or Idaho Department of Juvenile Corrections (IDJC).
- **PRTF:** Psychiatric Residential Treatment Facility – A facility with federal (CMS) certification of PRTF, which allows full Medicaid funding.
- **RTC/RTF:** Residential Treatment Center/Residential Treatment Facility – A facility without federal (CMS) certification of PRTF designation which means therapeutic services provided will support determination of Medicaid funding allowances.
- **QRTP:** Qualified Residential Treatment Program – This is a facility designation made by CYFS and determines their ability to use Title IV-E federal funds for foster youth placement at a facility.
