# Introduction

The IGT is responsible for collaboratively coordinating and overseeing the implementation of the <a href="Jeff">Jeff</a>
<a href="D.Settlement Agreement">D.Settlement Agreement</a>. The purpose of the IGT is to provide a governance structure to oversee the implementation and operation of YES and Quality, Management, Improvement, and Accountability (QMIA) program. The IGT seeks to ensure that the state's policies and procedures promote the successful development and operation of a new and improved children's mental health system of care. This report is essential for maintaining transparency, guiding strategic direction, and ensuring the workgroup and subcommittees efforts align with the <a href="IGT Strategic Plan">IGT Strategic Plan</a> goals and the broader YES system of care.

# Roadblocks & Requested Support

- O ICAT Subcommittee Roadblocks: Rebuilding the workgroup and its membership as well as having the use of a virtual platform to meet monthly.
- QMIA Council Roadblocks: QMIA Council is working with the IWG regarding next steps for the QMIA Plan and is currently waiting for an update regarding YES compliance.
- One Kid One CANS Workgroup Support: Providing a presentation at an upcoming IGT meeting about the new overall decision support model.
- YES Communications Strategic Planning Workgroup Support: FYldaho is working to try to identify a way for the workgroup to have regular youth representative participation, or a new process for gathering youth input. If IGT has any assistance they can provide in the process, that would be helpful. The main difficulty is youth representatives are happy to participate, and have in the past, but changing responsibilities like schooling and employment can prevent long-term participation.

# **IGT Strategic Plan Goal Progress**

To ensure the workgroup and subcommittees efforts align with the IGT Strategic Plan and the broader YES system of care, the information submitted by the YES workgroups and subcommittees was compared to the current IGT Strategic Plan 2021-2024 goals and the ongoing work of the IGT. Through the implementation of the YES Workgroup & Subcommittee Review Report, progress has been made on Goal 1, specifically Goal 1.a that the "IGT will identify a clear and actionable process for gathering information, accessing and assessing data, supervising or monitoring committees and workgroups, and securing project support (including administrative support) that includes the identification of whom will accomplish what by when and what may be done in the event that resources are not available to meet all of the IGT's obligations or priorities." This includes advancements on Goal 3, which states that the "IGT will effectively execute oversight, monitoring, and collaboration with councils, workgroups, and committees to move the YES system of care implementation forward." Progress continues through the YES workgroup and subcommittees focused discussions and future tasks related to Goal 2. as it states that "the IGT will prioritize the implementation and oversight of these program elements: 1. Care/Case Management, 2. Crisis System, 3. Intensive Services Continuum (treatment, foster care, etc.), 4. Due Process for YES Class Members, 5. QMIA data and other essential data, and 6. Expanding access and sustainability." By providing the requested support for additional membership from the YES workgroups and subcommittees, the IGT will make further progress on Goal 4, specifically that the "IGT will build a community of support through stakeholder involvement and communication that helps build broad public support and utilization of services such that sustainability happens."

# Membership

ICAT Subcommittee is the largest group with a total of 30 members. The most requested membership position is an Idaho Tribe Representative, with 4 out of the 6 total YES workgroups or subcommittees requesting representation. None of the YES workgroups or subcommittees reported losing any members in the last three months.


